Resolution # 18/09/09/008 Moved by Councillor Aiston and seconded by Councillor Gibson

**WHEREAS** the world's economy has entered into a period of slow economic growth; **AND WHEREAS** governments throughout the world have introduced various stimulus packages to encourage economic growth;

**AND WHEREAS** the North American market for a wide variety of construction supplies and manufactured goods used in municipal infrastructure projects is highly integrated;

**AND WHEREAS** the United States of America is Canada's largest trading partner and a signatory of the North American Free Trade Agreement, and both countries benefit from a highly integrated market for construction supplies and related manufactured goods used in municipal infrastructure projects;

**AND WHEREAS** Canadian municipalities are supportive of the Free Trade agreement between Canada and the United States which has existed for many years;

**AND WHEREAS** the Government of the United States has introduced infrastructure stimulus packages including the American Recovery and Reinvestment Act (ARRA) which includes a "Buy American" provision for steel and other manufactured products;

**AND WHEREAS** these restrictive provisions which are contrary to the spirit of free trade will prevent Canadian companies from bidding on contracts which contain the "Buy American" provisions at the municipal and state levels in the United States since NAFTA and The Agreement on Government Procurement of the World Trade Organization do not nullify such provisions at those levels:

**AND WHEREAS** Canadian stimulus infrastructure programs do not contain any restrictions on manufacturers from other countries, including the United States, bidding on such contracts in Canada;

**AND WHEREAS** Canadian-based companies may be adversely affected by these restrictions possibly leading to lay-offs and financial losses and could lead to the erosion of their overall ongoing viability;

**AND WHEREAS** the economic outlook of local employers is of municipal interest because of the potential negative effects of business failures on local quality of life, community vibrancy and the property tax base;

**AND WHEREAS** Canadian municipalities have the right to undertake measures to protect their local economies and quality of life;

**THEREFORE BE IT RESOLVED THAT** municipalities express support for the spirit of free and fair trade between the United States and Canada and assert that the restrictive "Buy American" provisions in the American Recovery and Reinvestment Act are contrary to that spirit of free trade;

**AND BE IT FURTHER RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby support the Federation of Canadian Municipalities (FCM) in its stance to support the Government of Canada and the Canadian Manufacturers and Exporters and other

stakeholders in their efforts to urge the United States Congress to repeal "Buy American" requirements in federal stimulus packages;

**AND BE IT FURTHER RESOLVED THAT** FCM urge the US National League of Cities and the US Conference of Mayors to also support the spirit of this resolution and the spirit of free trade, so that municipalities on both sides of the border can continue to procure supplies in the fairest and most efficient manner;

**AND BE IT FURTHER RESOLVED THAT** the United Townships of Head, Clara & Maria and the FCM support municipalities who choose to adopt procurement policies which favour free and fair trade by ensuring that the managers of local infrastructure projects, including environmental projects such as water and wastewater treatment projects, procure goods and materials required for these projects only from companies whose countries of origin do not impose trade restrictions against goods and materials manufactured in Canada;

**AND BE IT FURTHER RESOLVED THAT**, given that the Prime Minister, the Premiers and the US Chamber of Commerce have recently called for bi-lateral negotiations to resolve this issue, that this Council allows time for a negotiated resolution of this matter and should this matter not be resolved in a way that results in the lifting of the trade restrictions, that this Council proceed to amend its Procurement By-law to include a clause that states that we will only purchase equipment and do business with companies whose countries of origin do not impose trade restrictions against goods and materials manufactured in Canada.

c. Report #04/09/09/206 - Tooley Severance Road Maintenance Agreement

WHEREAS Council has amended its Zoning By-law to allow severance and building on properties that do not front on Municipal roads to encourage growth within the municipality; AND WHEREAS in order to facilitate any maintenance issues with private roads within the municipality a Municipal Road Construction Minimum Standards Policy was created; AND WHEREAS Mr. & Mrs. Tooley have applied for a severance of a large parcel of land in Bissett Creek that will not front on a Municipal road;

**AND WHEREAS** the County requested an agreement between the property owner and the municipality in order for consent to be granted;

**AND WHEREAS** the agreement protects the municipality and ratepayers from ever assuming responsibility for the maintenance of this private road amongst other things;

**THEREFORE BE IT RESOLVED** that the Council of the United Townships of Head, Clara & Maria does hereby recommend that the agreement be endorsed and registered on title. Carried

**WHEREAS** the Town of Amherstburg has requested support for its resolution in modifying the calculation of Property Assessment for solar energy operations;

**AND WHEREAS** it makes sense to offer some type of rebate or reduced rate to unconventional land uses due to projects which are being encouraged by the Provincial Government to solve an energy problem in an environmentally friendly way;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby support the Town of Amherstburg and request that the Province, specifically the Ministry of Finance, continue with consultation with Municipalities and the Solar Industry to reach a fair and equitable property assessment valuation method for these operations;

**AND FURTHER THAT** a copy of this resolution be forwarded to our MPP, AMO and the Town of Amherstburg.

**WHEREAS** the Gas Tax funds are legislated to be used within three years of receipt or returned; **AND WHEREAS** nearly \$4,000 of Gas Tax funds needs to be used by the end of 2010 or returned;

**AND WHEREAS** the costs for garage repairs will likely exceed our budgeted amounts due to higher than anticipated costs for the roof project and the requirement for 2/3 of the garage door replacement and heating system projects;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria do hereby agree to remove up to 100% of the Gas Tax funds to use towards the allowable garage roof project which fulfills our obligations by contributing to increased energy efficiency. Carried
