b. Zoning By-law Exemption Report #06/11/09/203 Resolution #06/11/09/003 Moved by Councillor Aiston and Seconded by Councillor Reid

**WHEREAS** a ratepayer has contacted the Municipality with respect to requirements for a building permit;

**AND WHEREAS** it has been determined that the property area is too small by 75 m<sup>2</sup> to be compliant with the zoning by-law;

**AND WHEREAS** it has been determined that the property owner purchased additional land in 2002 in order to ensure that they had the appropriate area to build once they were ready to retire and completed the appropriate severance request and subsequent purchase;

**AND WHEREAS** the current zoning requirement of 2,025m<sup>2</sup> was in existence at the time of the severance and purchase of additional land;

**AND WHEREAS** it then amounts to employee oversight at the time of the severance and is in fact no fault of the landowners;

**AND WHEREAS** the Council of the United Townships of Head, Clara & Maria fully recognizes the legislative requirements of the Planning Act and does not wish to set a precedent which may be used by another ratepayer to avoid the process of a minor variance application;

**AND WHEREAS** Council believes that this unique situation warrants a remedy at no additional cost or hardship to the ratepayer;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby grant an exemption from the Municipal Zoning By-law 2004-12, as amended, without the process of an Minor Variance application due to the fact that employee error or oversight here or at the County during the severance process resulted in the discrepancy. Carried
