• Report #21/05/10/203 – Mandatory Septic System Inspection

Resolution #21/05/10/002

Moved by Councillor Reid and Seconded by Councillor Foote

WHEREAS provincial concern over groundwater and other environmental protection has resulted in the consideration of a Mandatory Septic System Inspection Program;

AND WHEREAS most rural municipalities, including Head, Clara & Maria, have 100% of their residences and businesses on private water systems consisting of dug and drilled wells and private, individual septic systems as has been for many decades;

AND WHEREAS there is little evidence of source water contamination due to malfunctioning septic systems across the province and there has never been such a case in our Municipality;

AND WHEREAS the home owner has the most vested interest in maintaining their septic system in proper working order to ensure continued use and in order to protect their private water supply;

AND WHEREAS the installation of septic systems in rural communities is becoming increasingly regulated now, more so than in the past with the use of licensed contractors, installation permits, installation inspections, etc. thus insuring properly functioning systems are built;

AND WHEREAS adequate legislation currently exists to deal with malfunctioning septic systems;

AND WHEREAS the Council of this municipality feels strongly that any mandatory inspection program is redundant;

AND WHEREAS it can be argued that the frequent cases of large Municipal sewage systems overflowing into lakes and rivers as a result of large rainwater events is a greater public health hazard to a much larger segment of the Provincial population than malfunctioning septic systems;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby request the province not institute any Mandatory Septic System Inspection Program;

AND FURTHER THAT the Province make better use of the funds that would be necessary to implement any Private Septic System Inspection Program by continuing to direct their efforts to remedy the much more dangerous situation of malfunctioning Municipal sewage treatment facilities;

AND FURTHER THAT a copy of this resolution be forwarded to MPP John Yakabuski, MP Cheryl Gallant, Premier McGuinty, the County of Renfrew, the Minister of Municipal Affairs and Housing, the Minister of Finance, AMO and all neighbouring municipalities for support.

WHEREAS the Trans Canada Highway 17 is a major transportation link which runs throughout our municipality with a tourist traffic volume which increases dramatically during the warmer months;

AND WHEREAS changing weather patterns have resulted in increased traffic both earlier and later in the year, outside of normal park opening times;

AND WHEREAS the road-side parks are opened for a short length of time, limiting the availability of washroom and rest stop facilities requiring travellers to use local business facilities often without corresponding compensation;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby request that the provincial government commits to reviewing the current structure of its road-side park and rest area schedule with a goal towards increased flexibility depending on changing weather patterns and increased demand;

AND FURTHER THAT this resolution be forwarded to Premier McGuinty, our local MPP – John Yakabuski, John Baird - Minister of Transport, Infrastructure and Communities, Kathleen Wynne - Ontario Minister of Transportation, the Association of Municipalities of Ontario, The County of Renfrew and all local municipalities for support.
