- 4. Upgrades to the municipal and garage septic systems;
- 5. Enhancements to Old Mackey park in the form of a covered structure which could support cooking and washing for increased usage;
- 6. Potential hiring of a student to monitor the park usage:
- 7. The construction of a patio at the back of the hall;
- 8. High Speed internet service:

BACKGROUND/EXECUTIVE SUMMARY:

Self Explanatory. The above list included the issues which were openly discussed at the public meeting. There are some issues of concern with liability, ownership etc. of the fire equipment which will be investigated prior to actions being taken.
