i. Report #13/06/13/1201 - Lobby for Change in Election of Head of Council Resolution # 13/06/13/004

WHEREAS the Council of the United Townships of Head, Clara & Maria has discussed the situation of having few members of the public run for political office and losing a viable candidate in a contest for Head of Council:

**AND WHEREAS** in any contest there is only one winner with the non-elected candidates being refused a seat when they may have received more votes than some of those running for Council or where there were only 3 candidates for the 4 remaining seats on council;

AND WHEREAS a solution may be to amend current laws to allow all seats to be elected at large and have a Head of Council elected by the five members after the general election;

THEREFORE BE IT RESOLVED THAT the Council of the United Townships of Head, Clara & Maria does hereby agree to lobby the province to request that they reconsider the existing election rules so that smaller municipalities may benefit from utilizing the services of the few interested individuals who run for Council who receive the most votes.
