Large Appliances – fridge, stove, freezer etc.	\$10 each
Boats – no matter the material	\$3 per linear foot
Containers per cubic yard	
Loose Household Waste	\$10 per cubic yard
Demolition/construction Waste - wood products, drywall and insulation products	\$20 per cubic yard
Asphalt Shingles	\$30 per cubic yard
Compacted material	\$30 per cubic yard
Railway Ties	\$5/tie
All Other Material	\$40 per cubic yard
Contaminated Fill (See Schedule "J") Suitable for Daily Cover	\$40.00/tonne or \$20/cubic yard

Highway Accident Refuse – non-hazardous	\$100/cubic yard
