## MUNICIPAL TAXES DUE

Tax bills will be mailed out the first week of March to be due March 31st 2013. The first installment of municipal taxes is set by legislation at 50% of the taxes owing the previous year.

Although dependant on when the county and the other area municipalities finalize their budgets and freeze rates, HCM usually sets the remaining two tax installments to be due at the end of each of July and October.

For 2013 staff and Council prepared a budget which allowed for a reduction in your residential tax rate by 4.22% or \$11.56 of taxes owing per \$100,000 of assessed value.

The County's rate on its portion of taxes will be an increase of .20% or .73 cents per \$100,000 of assessed value. The provincial education rates were reduced by .009% or \$9 per \$100,000 assessed value. The County also sets tax ratios (sometime in May) which need to be allocated to determine a final tax rate.

All of these variables, including your most recent property assessment, need to be determined and considered before you will know whether your tax bill for 2013 will ultimately increase or decrease. At this time, we can not know what the final rate is.

# MMAH Councillor Guide

## Council Representative Role

“The Integrity Commissioner reports to council and performs in an independent manner. His or her role is to perform the functions assigned by council with respect to the application of a code of conduct for members of council and local boards as well as the application of procedures, rules and policies governing the ethical behaviour of members of council and local boards.

The Commissioner’s functions may include conducting inquiries into complaints from council or a local board, a member of council or a board, or a member of the public. If the Commissioner reports that a member of the council or local board has contravened the code of conduct, the municipality may impose a penalty in the form of a reprimand or a suspension of pay for a period of up to 90 days.

The municipal Ombudsman’s function is to investigate, in an independent manner, decisions, recommendations and actions of a municipality, local boards or certain municipal corporations.

In addition, section 239.2 of the act provides that municipalities may appoint investigators for closed meetings. Should a municipality not appoint an investigator, the Ontario Ombudsman is the closed meeting investigator, by default, for the municipality (see **Public Business is the Public’s Business** on page 30 below).

The Auditor General may assist council in holding itself and municipal administrators accountable for the quality of stewardship over public funds and achieving value for money in municipal operations. The Auditor General’s responsibilities do not include the responsibilities of the municipal auditor.

The Municipal Act, 2001 authorizes a municipality to establish a public registration system

for lobbyists and to do other things in relation to the lobbyist registration system, such as establishing a code of conduct for lobbyists and prohibiting former public office holders from lobbying for a designated time period.

Other statutes may require specific or general codes of conduct as well. For example, section 7.1 of the Building Code Act, 1992 (BCA) requires municipalities to establish and enforce a code of conduct for the chief building official and inspectors. Municipalities may choose to include the code of conduct in their building bylaw. The BCA outlines the purposes of the code of conduct and requires that the code of conduct provide for its enforcement.

The code of conduct must include policies or guidelines to be used in responding to allegations that the code of conduct has been breached and must set out the necessary disciplinary actions. The BCA also requires the municipality to ensure that the code of conduct is brought to the attention of the public.

## Stewardship Role

The public may view council as responsible for ensuring that the municipality’s financial and administrative resources are being used as efficiently as possible, and in a way that is consistent with council’s objectives. To refer back to section 224 of the Municipal Act, 2001, part of your role, together with the rest of council, is to ensure that administrative policies, practices and procedures are in place to implement the decisions of council and to maintain the financial integrity of the municipality. All of this can be promoted through good policy and monitoring practices.”

## Carefor Volunteers will help with Income Tax Returns

Volunteers trained by Canada Revenue Agency will be available from March 4 to April 5 to assist individuals on limited incomes with their income tax returns again this year. This includes, but is not limited to, students, new immigrants, pensioners, recipients of social assistance and individuals on disability pensions.

For the purposes of this program, limited income is defined as \$30,000 for an individual, and \$40,000 for a couple, with an additional \$2,500 allowed for each child.

**This assistance is only available till April 5. There will be no extensions so be sure to get your information in early.**

Tax forms may be dropped off at the Municipal Offices in Point Alexander and Stonecliffe and the Long Term Care in Deep River between 9:00 am and 4:00 pm, Monday to Friday.
