## 2. Unfinished business

The subcommittee was of the mind that the licensing agreement we were seeking, the installation of the bar etc., was all geared to bring in monies to support community activities and perhaps help off-set some costs of running the hall. Stats for expenses in the hall were not available to the sub- committee at this time but it was felt that by year end we would have an idea of any increases incurred with all the activity of late. ## 50/60 Committee questions for resolution;

1. Volunteers to pay or not

There was some discussion over this issue and the general consensus is some common sense is should prevail, keeping in mind these are volunteers and have volunteered their time to the planning and running of an event. pay. If food is perishable (and not going to needed at an event in the near future) it may be best to consume it. Other scenarios such as use of vehicles for shopping, checking out bands, putting up posters this is part of volunteering for planning the event.

## 2. Tip Jar versus Donation J ar

This question was also answered and sent back to HCM Recreation Committee for further review. According to Sept 2014 minutes the Tip Policy was at the discretion of the bartender. They can split the tips or donate back to the event. You should keep in mind that at the time this decision was made the Server was asked to "work" the bar. That being noted it is decided that the Sub-committee should decide and go with their decision. However, some events will use a tip jar.

## 3. Purchase of ergonomic mats

Can the rec committee purchase some for the kitchen to prevent back issues?
The ergonomic mats were discussed and although the HCM Recreation committee is in favour of purchasing mats it has not been budgeted for 2015 and so must wait until year end to be considered for the 2016 budget. IT is also important to note that proper shoes should be worn when working for long periods on this hall's floors. Also that when mats are researched for purchase they will need to be of the industrial standard and not necessarily what we can use in our home.

Pickle Ball - Debbi Grills will work with another township re setting up this game. The question of whether or not we could use our heli-pad to paint lines for outdoor use came up and will need checking out by Melinda Reith.
