If these properties are being included in numbers to determine policing costs. (e.g. cell phone towers) – these are not commercial – no calls for policing for this area will be required</li> <li>Vacant land - is there a process for applying a base amount (rate) for these properties?</li> <li>With the increased policing costs some seasonal residents state that they are paying more for their cottages than full time homes; therefore the raised costs may deter owning seasonal property (some municipalities depend on their high numbers of seasonal residents for tax base purposes and future growth</li> </ul>
