Moved by Councillor Foote and Seconded by Councillor Grills **WHEREAS** the Municipality of Head Clara and Maria has been unsuccessful in obtaining auto extrication services from its neighbouring Municipalities for a 30 km stretch of Trans-Canada highway 17 through the Municipality;

**AND WHEREAS** this route is in fact designated as part of the Trans-Canada highway system;

**AND WHEREAS** the municipality is attempting to develop an alternate solution, until such time as one might be arranged, this option be available;

**AND WHEREAS** the Canadian military base, Garrison Petawawa, is quite close to this section of highway;

**AND WHEREAS** Garrison Petawawa has equipment and trained personnel to conduct auto extrication;

**AND WHEREAS** the military conducts regular training exercises to keep staff fully qualified;

**AND WHEREAS** real life situations provide some of the best training opportunities;

**THEREFORE BE IT RESOLVED THAT** the municipality of Head, Clara and Maria petition the federal government through the Ministry of Defence to allow Garrison Petawawa to respond to truly life threatening situations as determined by Renfrew County Paramedic services and provide auto extrication services;

**AND FURTHER THAT** staff is directed to circulate a copy of this resolution to our MPP John Yakabuski, our MP, Cheryl Gallant, the Ministry of Community Safety and Correctional Services, Premier Wynne, the Office of the Fire Marshal, the County of Renfrew and area municipalities for information.

#### Resolution #19/02/16/005

Moved by Councillor Grills and Seconded by Councillor Foote **WHEREAS** the Municipality of Head Clara and Maria has been unsuccessful in obtaining auto extrication services from its neighbouring Municipalities for a 30 km stretch of Trans-Canada highway 17 through the Municipality due to the reluctance of those neighbours to leave their own public underserviced;

**AND WHEREAS** many suggestions received are not practical simply because our population does not have the potential for staffing either a professional or volunteer fire department;

**AND WHEREAS** it is hoped that the Town of Laurentian Hills and the Town of Petawawa would be willing partners;

**BE IT RESOLVED THAT** the municipality of Head, Clara and Maria does hereby request that the Town of Petawawa consider assisting in a resolution to the existing problem by offering back up to Laurentian Hills through a mutual or automatic aid agreement to fill vacancies within that community while Laurentian Hills volunteers respond to auto accidents on Highway 17 in Head, Clara & Maria on a pay per service basis so that no municipality is left underserviced and the travelling public are protected;

**AND FURTHER THAT** staff is directed to circulate a copy of this resolution to our MPP John Yakabuski, our MP, Cheryl Gallant, the Ministry of Community Safety and Correctional Services, Premier Wynne, the Office of the Fire Marshal, the County of Renfrew and area municipalities for information.

**AND WHEREAS** a draft press release has been provided for Council review and approval;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby approve the release of the draft press release, as amended at this meeting to the media as soon as possible;

AND FURTHER THAT staff is directed to circulate a copy of this resolution to our MPP John Yakabuski, our MP, Cheryl Gallant, the Ministry of Community Safety and Correctional Services, Premier Wynne, the Office of the Fire Marshal, the County of Renfrew and area municipalities for information. Resolution #4

Resolution #19/02/16/007

Moved by Councillor Grills and Seconded by Councillor Foote **WHEREAS** the Municipality of Head Clara and Maria has been unsuccessful in obtaining auto extrication services from its neighbouring Municipalities for a 30 km stretch of Trans-Canada highway 17 through the Municipality due to the reluctance of those neighbours to leave their own public underserviced;

**AND WHEREAS** it is not feasible for Head, Clara & Maria to have its own Fire Department, volunteer or professional;

**AND WHEREAS** in response to a letter of request for assistance to the province in November of 2015 Head, Clara & Maria was told that the province's obligation is to pay an hourly rate to fire departments for the provision of auto-extrication services and had no suggestions as to how to proceed where a community did not have a fire department;

**AND WHEREAS** the Ministry of Community Safety and Correctional Services Public Fire Safety Guideline PFSG 04-24a-12 entitled *Liaison With Other Agencies at Vehicle Extrication Incidents* states "In the case of any one of the emergency services not being at the scene, those in attendance would have to assume some of the responsibilities of the other services and in all cases, the priority would be the safety and well being of victims";

**AND WHEREAS** the County of Renfrew Emergency Services and the Upper Ottawa Valley detachment of the Ontario Provincial Police which services this municipality are both aware of the dissolution of the North Renfrew Emergency Response Unit and the resulting lack of service in Head, Clara & Maria;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby advise both the County Department of Emergency Services and the Ontario Provincial Police that when responding to calls in Head, Clara & Maria they should be prepared to "assume some of the responsibilities of the other services" and equip themselves as necessary to do so as we have not been able to obtain assistance from either our neighbours or the province at this time.

Resolution #19/02/16/008

Moved by Councillor Foote and Seconded by Councillor Grills **WHEREAS** some members of Council have concern with the potential for liability due to the lack of auto-extrication services along highway 17 through a section of Head, Clara & Maria;

**AND WHEREAS** it is fact that a municipality is not required to have a fire department if a risk assessment has been conducted and has shown that it is not feasible;

**AND WHEREAS** two municipal representatives of the Ontario Fire Marshal's office in 2011 advised that continued participation in the joint auto-extrication agreement was not a legal requirement for Head, Clara & Maria;

**AND WHEREAS** the municipal insurer, in 2011 advised that there was no increased liability for the municipality in not providing auto-extrication services;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby direct staff to consult with the municipal solicitor and liability insurer to obtain opinion on the potential for liability with this current situation. Defeated Unanimously

#### Resolution #19/02/16/008-A

Moved by Councillor Grills and Seconded by Councillor Foote **WHEREAS** the County of Renfrew Warden, Peter Emon has been cited in the on-line *Ottawa Valley Business* newsletter dated February 16, 2016 as stating that it is the responsibility of the municipality to provide auto extrication services along Highway 17 in Head, Clara & Maria;

**AND WHEREAS** the Council of the United Townships of Head, Clara & Maria are concerned for the welfare of the travelling public but conversely are not in a position due to distance and population to provide the required services;

**THEREFORE BE IT RESOLVED THAT** the council of the United Townships of Head, Clara & Maria does hereby request that Renfrew County provide documented legal opinion to support Warden Peter Emon's public statements to the media. Carried Unanimously

Moved by Councillor Grills and Seconded by Councillor Foote **WHEREAS** the lack of auto-extrication services along a section of Trans Canada Highway within Head, Clara & Maria has resulted in coverage in the local and national media;

**AND WHEREAS** statements made by Warden Peter Emon of the County of Renfrew are not based in fact, are inaccurate, defamatory and not representative of the County Council as the issue has yet to be debated at the county level;

**THEREFORE BE IT RESOLVED THAT** the Council of the municipality of the United Townships of Head, Clara and Maria does hereby authorize staff to forward this resolution and letter of concern to the Council of the County of Renfrew for discussion and action;

**AND FURTHER THAT** the Council of the County of Renfrew release a media retraction for the inappropriate and erroneous statements made by the Warden.

**AND FURTHER THAT** staff is directed to circulate a copy of this resolution and letter to MPP John Yakabuski, MP, Cheryl Gallant and area municipalities for information.

**AND WHEREAS** statements by Warden Peter Emon, representing the County of Renfrew are inaccurate and not helpful to the resolution of the auto-extrication problem;

AND WHEREAS the issue has yet to be debated at the county level;" Carried Unanimously

**Action**: Council directs staff to contact the Ministry of Transportation requesting signage be placed within the municipality advising of lack of auto-extrication services.

Mayor Gibson made a request to see what steps should be taken next. Councillor Grills suggested notice/reminder letters to those involved advising that a solution has not yet been attained?

**Action**: Clerk to set a meeting with Council, the Ontario Provincial Police, the Renfrew County Paramedics, Jim Hutton, County of Renfrew CAO, Garrison Petawawa, all involved municipal CAOs, their fire chiefs, and heads of council (Laurentian Hills, Laurentian Valley, Town of Petawawa, and the City of Pembroke) and the representative of the Ministry of Community Safety and Correctional Services with a date in the next 2-3 weeks to attempt to resolve this issue.

- Project 808143 Improvement of Lacroix Park and Boat Launch, for a contribution of up to \$8,000, total project costs of \$19,990; and
- Project 808157 Improvement of Mackey Dock and Boat Launch Facility, for a contribution of up to \$8,000, total project costs of \$19,990;

**AND WHEREAS** Council is committed to funding and delegating authority for entrance into the contribution agreement with the Federal Economic Development Agency for Southern Ontario (FedDev Ontario);

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby authorize the contribution agreement for the projects as identified above and delegates authority for implementation of this agreement and project to the Clerk/CAO Melinda Reith.

**WHEREAS** Council has provided support for planning and submission of a funding request through the Canada 150 program for a Homecoming to celebrate Canada's 150th;

**AND WHEREAS** Council deems it important to document Head, Clara & Maria's contribution to Canada no matter how significant; to assist in hosting a historic event celebrating residents, past and present as worthy of being celebrated no matter their accomplishments, while focusing on documenting municipal history to provide a legacy for future generations;

**AND WHEREAS** eventually, a decision will be required to determine whether the project will continue at a certain level, be streamlined or be cancelled;

**AND WHEREAS** Council has reviewed a draft budget prepared for application to the Canada 150 program for 2017's Homecoming;

**THEREFORE BE IT RESOLVED THAT** the Council of the United Townships of Head, Clara & Maria does hereby authorize staff to proceed with the project, having Mayor Gibson endorse a letter of support for application to the Canada 150 funding through Heritage Canada on Council's behalf;

**AND FURTHER THAT** tentatively confirmed attendance of at least 150 people be obtained by April 2016 in order to proceed with the event;

**THAT** Council does hereby agree to underwrite the project in the amount of \$5,000 in order to proceed with planning, acknowledging that other sources of funding will be obtained and used to offset costs;

**THAT** staff and volunteers are encouraged to seek and obtain corporate sponsorship;

**THAT** the request for funding letter sent to ratepayers for 2016 and 2017 identify Homecoming as its purpose;

**THAT** should funding from Canada 150 not be forthcoming, project plans be streamlined to ensure reduced costs as per an amended budget and a cost/revenue neutral event.
