## THE UNITED TOWNSHIPS OF HEAD, CLARA & MARIA

Recently the Townships of Head, Clara and Maria have partnered with the Healthy Kids Community Challenge of Renfrew County and have received funding to create a physical activity equipment lending hub at the Township hall.

The Healthy Kids Community Challenge is a Ministry of Health and Long Term Care funded initiative created to support the well-being of our children and to

create communities which are easier for children to lead a healthy life. The

Healthy Kids Community Challenge promotes healthy eating, physical

activity and healthy behaviour for children.

With the funding that we have received we have purchased mountain bikes, helmets, paddle boards, kayaks, life jackets, fishing rods, a badminton set, hockey nets, footballs, soccer balls, basketballs, and volley balls. All of this equipment is **free** to borrow and anyone in the municipality can borrow it, including our summer visitors!

Not only did we purchase equipment for children, we purchased equipment for adults as well, as we feel that it is important that children have access to physical and recreational activities that include the whole family.

Two of the cargo containers located at the Township hall have been converted into the lending hub which will store all of the equipment. Anyone who is inter-

ested in borrowing the equipment can come to the Township office during regular hours, sign the rental agreement and liability waiver and borrow the equipment for up to two weeks. Depending on the demand of equipment, the two week period may be adjusted in the future. Equipment can also be signed out at the Library on Tuesday evenings from 6:00—8:00 pm or Saturdays from 12:30—3:00 pm if previously arranged.



With our lending hub nearly finished and running, we are beginning our second project with the Healthy Kids Community Challenge, creating a natural play space. Rec Committee often discussed putting a play structure at the Township hall to be available during community events. It has been noted at several community gatherings, especially at ball tournaments, that there is nothing available outdoors at the community centre for the children to play with. A natural play space will fit perfectly in our community—“a natural playground”.

We are still in the planning and design stages of the play scape and look forward to the building process in the upcoming months. Some of our ideas include an embankment slide, climbing tires and stumps, and a spider web rope. Again, we welcome and encourage feedback! ## A M E S S A G E F R O M M A Y O R G I B S O N

Hello all,

Well the big secret is out! The County, along with Papineau-Cameron Township and Lanark County, have had an agreement to purchase the CP rail line accepted by CP Rail. The total price was \$500 000 and is shared based on the percentage of line in each municipality. The County's share is \$360 000.

The purchase will be done in three phases starting in the east at Smith's Falls and ending with our section and Papineau-Cameron's done last. It is anticipated this effort will take a couple of years to complete due to the complexity of the deal. As part of the deal, the purchasers have agreed to accept liability in return for the ability to proceed with any work on the line they may deem appropriate.

The next stage in the process will be looking at a committee structure and developing terms of reference for that committee.

The County has aerial photographed all of Renfrew County's section of the line to have a base record of the condition of the line at time of purchase. This was done using the Renfrew County paramedics drone and is very detailed so any changes made to the line from here on in can be easily identified.

Just recently the County signed a Memorandum of Understanding with the Pikwakanagan First Nation from Golden Lake. This understanding will enhance the already good working relationship between parties and will strengthen both parties position on mutually beneficial projects especially where Provincial and Federal grant monies are involved.

Locally, work is still progressing on our boat launches and users are pleased with the addition of the docks.

Canada Day celebrations are well under way and I encourage as many as possible to attend the 149<sup>th</sup> anniversary of our nation's foundation. Who among us can pass up a free lunch while socializing with your friends, relatives and neighbors?



**RE: IMPORTANT MESSAGE ABOUT A POSSIBLE CANADA POST LABOUR DISRUPTION**

**Please be advised:** We have received notice that a potential strike by Canada Post employees may occur. As a result, the delivery of HCM Property Tax Bills to residential property owners may be affected. A strike deadline has been set for July 1, 2016.

**Reminder:** It is still your responsibility to pay your tax bill by the required due date.

To avoid the possibility of not receiving your tax bill, you can view, download or print a PDF copy of your bill online at <http://www.townshipsofheadclaramaria.ca> by selecting [View Property Tax eBills](#) and registering. Not only will this ensure you receive your tax bill on time, but it will provide you with the opportunity to pay for it on or before the due date. In addition, by receiving and making your tax payment on or before July 31st, 2016, it will prevent potential late fee of 1.25% being added to your property tax account.

**Please note:** The eBill option will take effect immediately; however, you will not be able to view your July 2016 tax bill until it is processed. This routinely takes place on or before July 10<sup>th</sup>, 2016. Please visit the municipal website for more information on the eBilling registration process, additional information on viewing, downloading and/or printing a copy of your bill as well as payment options.

Therefore, do not wait until it is too late; make the switch today to online eBilling to receive an email notification when your bill is ready.







## FIRE SUPPRESSION ALTERNATIVES



Haven, a fire suppression safety device company from Carp, ON, had a display set up at June Jazaar at the request of our Community Fire Safety Officer, Bob Labre. This device is a great product for residences in HCM where there is no fire suppression capabilities and prohibitive costs with installing water sprinkler systems. Instead this product can be retro-fit into most ceilings with little expense, little disturbance and significant benefit. In case you missed them or would like more information on their product, this information has been taken from their website:



“The Haven ceiling mounted fire suppression device provides safety for you and your family by automatically discharging a heat-activated MSDS-safe super-fine mix of ABC dry suppression powder at operating temperatures of 135 degrees Fahrenheit. Designed to be discreetly installed in most ceiling cavities. Additional Haven fire suppression units can be installed for added protection in areas such as; kitchens, bedrooms, garages, furnace rooms, laundry rooms, play rooms, cottages and hunting camps and any where you want added, automatic fire protection. Engineered, tested and proven to provide effective fire suppression into a 16' x 16' area by suppressing the fire, providing you with life-saving time. Without any water damage from a small fire, clean up is quick and easy. Simply dry vacuum and wipe the affected area clean. ”

## FIRE SAFETY IN HCM

Reminder—Burn permits are required and fire restrictions are in effect from April 1st until October 31st. Council has amended our permits from daily to seasonal burn permits. Now you can come to the office and buy a permit that is valid for the entire season for \$5.00. It is important that applicants read the entire agreement and conditions before signing the permit. Without fire protective services, fire safety is a major concern in HCM. The burn permit is about fire safety and awareness and not so much the fee.

Please see the table of fines taken from the Ontario Court of Justice’s webpage ([www.ontariocourts.ca](http://www.ontariocourts.ca)). Burning without a permit during restricted periods can result in fines starting at \$200.

In Thunder Bay, ON two men were charged in 2010 for burning without a permit and fines associated with these charges ranged up to \$430.

Please take precaution when burning.

Ontario Regulation 207/96 under the *Forest Fires Prevention Act*

1.	Start fire under unsafe conditions	1(1)	\$200.00
2.	Start fire – fail to leave person in charge	1(2)	\$200.00

5.	Fail to extinguish fire	1(3)	\$200.00
6.	Unlawfully start fire without a permit	2	\$200.00
7.	Unlawfully tend fire without a permit	2	\$200.00

Ontario's Ministry of Transportation is targeting distracted driving this summer with a marketing campaign that urges people to put down the phone.

In Ontario, deaths from collisions caused by distracted driving have doubled since 2000.

Ontario data on collisions from 2013 show:

- one person is injured in a distracted-driving collision every half hour
  - a driver using a phone is four times more likely to crash than a driver focusing on the road
- If you have an A, B, C, D, E, F and/or G licence, you'll face bigger penalties when convicted of distracted driving:
- a fine of \$490, if settled out of court (includes a victim surcharge and the court fee)
  - a fine of up to \$1,000 if a summons is received or if you fight the ticket in court and lose three demerit points

### OPP WARN OF PRIZE SCAM SURFACING IN AREA

**(PEMBROKE, ON)** – The Upper Ottawa Valley Ontario Provincial Police (OPP) would like to warn residents of a lottery and prize scam that has recently surfaced in the area. The victim was contacted through the internet and was advised that they had won a large sum of money and in order to collect the winnings they would have to pay a fee. The victim then sent several money orders to Nigeria in hopes of collecting their prize. No prize was ever paid out and the incident was reported to police after it was realized they had fallen victim to a scam.

The OPP would like to remind everyone that legitimate lotteries do not require you to pay a fee or tax to collect winnings. Also, many lottery and prize scams want to trick you into providing your banking and personal information to claim your prize. In fact, the criminals will fraudulently use your personal information to steal your money. If a scam artist contacts you or if you have been defrauded contact your local police service or the Canadian Anti-Fraud Centre at 1-888-495-8501 or visit their website at [www.antifraudcentre.ca](http://www.antifraudcentre.ca)

There has been an increasing number of break ins in Head, Clara and Maria.  
Here are some tips from the OPP to protect your property:

- **Watch for suspicious people or activity in your neighbourhood.**  
Have a trusted neighbour keep an eye out while you plan to be away. Do not announce your absence over social media. (Or that of your neighbours)
- **Deter potential criminals.**  
Ensure outside lights work and consider motion sensor lighting.
- **Lock doors and windows, even if you're going out for a short time.**  
Install quality locks and a deadbolt on each outside door.
- **Prevent break and enters.**  
Keep garage doors and entry doors secured.
- **Avoid access by intruders.**  
Lock your vehicles at all times. Remove or secure valuables out of sight, even when in the garage.
- **Trees, shrubs and fences create hiding spots for criminals.**  
Keep your landscaping groomed and limit privacy fencing.
- **If you're going to be away, keep the grass cut or driveway shovelled.**  
Do not let newspapers or mail accumulate.

### OPP CHARGE SUDBURY MAN AFTER BREAK AND ENTERS IN LAURENTIAN HILLS AND HEAD-CLARA-MARIA TOWNSHIP

**(LAURENTIAN HILLS, ON)** – On the afternoon of June 16, 2016 the Upper Ottawa Valley Ontario Provincial Police (OPP) were called to a residence on Highway 17 in Laurentian Hills after it was discovered that a break, enter and theft had occurred at the residence earlier that day. Forced entry was made to the residence and items stolen included a computer, cash, prescription medication and a bicycle.

On the morning of June 18, 2016 police were called to a break, enter and theft that was discovered at the Head-Clara-Maria (HCM) Township Municipal garage on Township Hall Road. Tools were stolen and Township property was damaged. Later on June 18, 2016 police located and arrested a male pedestrian on Highway 17 in HCM Township that matched the description of the suspect in the municipal garage break in. The male was found to be in possession of items stolen from both break and enters.

As a result 46 year old Normand BOURGOUIN of Sudbury, Ontario has been charged with the following Criminal Code offences:

- Break, Enter and Theft – 2 counts
- Possession of Break-In Instruments
- Mischief Under \$5000 – 2 counts
- Possession of Property Obtained by Crime under \$5000 – 2 counts
- Fail to Comply with Probation – 2 counts

He was held for a bail hearing on June 19, 2016 and remains in custody until his next court appearance on June 27, 2016 at the Ontario Court of Justice in Pembroke.
