## T R A N S P O R T A T I O N

One of council's goals for 2016 is to determine whether or not there is a need for a new service in our community? Do you occasionally need to travel some distance for medical or health appointments and have a concern about driving or how you are going to get there? Maybe you normally drive but won't be able to after receiving some type of treatment and have a one off need for assistance? Maybe you just don't drive in cities?

**Or** are you able and willing to drive someone to an appointment in Pembroke, Renfrew, Ottawa or North Bay?

Council would like to determine if staff can play a part in providing a service of matching these two groups of people up. Can you drive a neighbour to an appointment? Do you need a ride? What has been proposed is that municipal staff become involved simply in matching people who need a ride up with those willing to give one. We would keep a list of available drivers; if and when you need one, you contact office staff and we'll match you up.

Of course we would have to work out details on liability, which vehicle, who pays for gas etc. but first we would like to determine whether there is a need and/or ability to provide the service in the first place.

## A MESSAGE FROM MAYOR GIBSON

Hello folks,

This article will deal with the biggest problem small Municipalities like us have from a Municipal staff point of view. Federal and especially Provincial governments regardless of the colour of the party in power are continuously downloading work and accountabilities to Municipal governments. More often than not this downloading is not accompanied by any financial assistance to execute the work.

The latest and one of the most concerning examples is the Province's Ministry of Municipal Affairs and Housing intention to download the work involved with the enforcement of residential rental maintenance standards to all Municipalities in the Province by making amendments to the Residential Tenancies act, 2006.

The Ministry is offering Municipalities two options:

**Option one** is to create interior and exterior property standards bylaws and enforce the Province's maintenance standards which are much too long for this newsletter.

**Option two** is to enforce the province's maintenance standards by appointing an inspector who will do the inspections and issue remedial work orders to the landlord as a result of a renter's complaint.

There are 93 municipalities in the province without exterior or interior property standards bylaws and 52 municipalities with partial bylaws. Any reader of the NRT will know how time consuming and costly the enforcement of property standards bylaws can become.

You can view the standards on line by looking at [Ontario Regulation 517/06](#).

Last year your Council decided to join a new group called the Rural Mayor's Forum of Eastern Ontario (RMFEO). This group has been successful in focusing the attention of the O.P.P. and MPAC to problems with the O.P.P. billing increases to smaller Municipalities. I will be bringing a draft HCM Council resolution to this Friday's RMFEO meeting to attempt to get endorsement of that group in opposing the Ministry's downloading of this enforcement that will do nothing but increase our administrative costs.

It's interesting to note that the 2006 census shows that HCM had zero renters.

## R E C R E A T I O N

The Recreation Committee has been extremely successful in hosting events over the past two plus years and has poured profits back into our community. Soon to be completed is a new play structure being installed at Old Mackey Park. It has taken some time but plans are underway to have them installed soon (perhaps completed by the time you read this).

As a lower tier municipality in Renfrew County, we have benefited from the County Healthy Kids program which was responsible for donating \$10,000 to purchase equipment for our lending hub which has turned out to be an undeniable success.

Crystal has worked hard to get the program up and running resulting in some happy equipment users. A popular item seems to be the paddle boards. Thanks for suggestions from users; we will streamline our processes for next year to make the system more user friendly for everyone. And don't forget, for winter we also have snowshoes and hiking poles for use; in all sizes.

A second project, funded mainly by the Healthy Kids program but supplemented by the Recreation Committee is a new "natural play scape" soon to be installed behind the community centre in Stonecliffe. Finally, it's determined that it is OK for kids to play on hills, trees and rocks again. Watch for these improvements to be completed before the snow flies.

Although we will not know whether or not we have been successful until some time later this year; an application has been submitted to the

Trillium Foundation to erect player and spectator benches and shelters for the ball diamond which has seen a recent resurgence in use, thanks in a large part to Paul (John-Joe) Sarrazin. Again, some funds required for this project will be donated by the Rec Committee.

Thank you to everyone who volunteers their time to plan and host events; and to all of you who come out to support them. We do more together.

On that note, we would like to thank Adam Desjardins for coming forward to host a ball tournament on Saturday, October 8. One of the purposes of the Recreation Committee is to assist residents in hosting events. Adam came forward with an excellent idea and a group of people willing to help him, and along with Rec Committee volunteers planned another event proceeds of which will flow back into recreation programming in our community. Thank you to Adam and everyone involved with this project.

I've recently had a conversation with a long time resident who is missing broomball. She had some excellent ideas for continuing physical activities during the winter months as not everyone is a snowmobiler. We tossed around ideas such as snow baseball or broomball.

Staff and rec volunteers are here to help you. If you have an idea, get in touch with us and we will be happy to help you work out the details. All we need is some lead time, and a few people willing to help out.

To date we have ongoing exercise mornings – Monday, Wednesday and Fridays from 9:00 – 10:00 and Yoga – Thursdays at 11:00. Pickle ball is booked for Tuesdays at 1:00. Each of these programs were implemented by residents and supported by Council through free use of the hall; and in some cases, some equipment support.

# THE PLANNING ACT AND SMALL RURAL ONTARIO

Recently Council and staff have heard from a number of residents of Head, Clara & Maria concerned about the provincial Planning Act and the Official Plan and implications which directly affect their ability to use their own property.

The 2005 Provincial Policy Statement (PPS) which is a document prepared by the Ministry of Municipal Affairs to inform local official plans and zoning by-laws, made changes which encourage what they call “infilling” and reduce the need for increased infrastructure.

Some of those components included eliminating the reliance on private water and sewer and limited lot creation or severance under specific circumstances.

After that policy plan was rolled out, rural municipalities complained, as these policies significantly decreased the freedom in use of rural private lands.

The 2014 PPS reflects some of those changes which have been reflected again in the County of Renfrew Official Plan. 2015-2016 brought about a review of the County Official Plan. In October of 2015, Council and staff met with county planners to discuss the review and implications on Head, Clara & Maria and its property owners.

Some areas of concern and identified by Council include:

- Restrictions on lot creation, or severance along private roads;
- Restrictions on lot creation, or severance on private roads which front or enter onto Highway 17;
- Restrictions on development along “highly sensitive” or “at capacity” lakes.

Some of these restrictions have been in place since 2005, some are new.

The challenge this poses to property owners is that they are restricted in enjoying their property and in using it for what was the intended purpose for some people, as retirement income or pension.

Council and staff would like to assure residents and property owners that we have taken every opportunity in the past to oppose these changes and have most recently created a resolution to be circulated to the review committee, every municipality in Renfrew County and municipalities within the province to reflect our position.

Council and staff feel strongly that although prudent land use planning is required, that rules created for urban areas are not specifically transferrable to rural areas.

Specifically we are going to request from the County that an exemption is provided for Head, Clara & Maria to allow severance in these areas. Council believes that property owners should have the right to enjoy their own properties, to be able to follow through on long held plans to sever and sell 100 plus acre tracts of land to finance their retirements. Our Council is working for you. (MR)

And is looking for donations of wild game. To qualify, all game must be legally obtained under a valid hunting, trapping or recreational fishing licence **and** donated to be served at the event. For each donation we must keep a list of all persons who donate uninspected meat containing each donor's name, address and telephone number in full, and, the name of the species from which the donated meat was obtained. Terry Lamure has agreed to be our chef, other volunteers welcome.

UNFORTUNATELY MIGRATORY BIRDS SUCH AS DUCK AND GEESE ARE NOT ALLOWED UNDER THE PROVINCE'S REGULATIONS!

### The law

- You can serve wild-caught fish or game wildlife to the public at charitable events, if you follow certain rules.
- You don't need a permit or authorization to do this.
- You can't serve a species that is endangered or threatened.

### Applicable rules

By law, you must do *all* of the following:

- serve only wild-caught fish or game wildlife that was
  - legally obtained under a valid hunting, trapping or recreational fishing licence **and**
  - donated to be served at the event
- host the event for a charitable purpose and use all profits from the event for that purpose
- record all revenues and expenditures and the manner in which the profits were used for the charitable purpose and keep these records for 1 year after the event
- notify your local medical officer of health (at your local public health unit) in writing about your event at least 5 days before it occurs

You must also:

- keep donated wild-caught fish or game wildlife separate from inspected meat (commercial products)
- keep a list of those who donated the wild-caught fish or game wildlife and attendees of the event
- notify all attendees that uninspected wild-caught fish or game wildlife will be served at the event. This notice must be printed on each ticket and posted at a conspicuous place at the entrance to the event venue.
- keep a list of all patrons that attend the wild game dinner and must provide a copy of the list to a public health inspector upon request. The list must contain each patron's name, address and telephone number in full.



## WASTE MANAGEMENT

After some growing pains we are getting into the groove of new recycling and garbage collection processes. Bill has been collecting both since July and is now seeing the benefits of our changes.

How did we get here? Why did we change?

In 2015 staff began a review of our waste management program and processes in a large part due to directive from the Ministry of the Environment (MOE). Of significant importance is our need to comply with the covering of the garbage cell at our landfill on a daily/weekly basis. Council and staff are working with our advisors and MOE rep to work out a plan to meet our legislated requirements AND keep our operating costs low.

Once again, regulations which are created for a larger operation are being imposed on small rural municipalities. When we addressed some of our issues with our MOE Rep and questioned whether or not our current operations were not meeting the intent of the legislation, if not the specifics of our plan, we were told that the plan had to be enforced, no matter the costs or need. It was likened to breaking a traffic law. It wasn't that our operations were not being managed properly, but that we were not following the law.

This has led us to the change in operations. With the bins we purchased to hold materials, the plan is to use them for recycling as well as waste. With the waste being held in bins, there will be a need to cover the cells (costs of contractor and equipment) less frequently, decreasing overall operation costs.

The move to collecting recycling in-house was partially an operational challenge concerning the transfer of garbage across the provincial border and the lack of proper control of records. With the bins, our recycling amounts are properly recorded resulting in us receiving appropriate compensation through the Blue Box Program funding program through Stewardship Ontario and other programs.

So a recap on which plastic bags go in the recycling container:

Grocery bags, flyer and grocery sacs, plastic outer wrap (from bottled water, toilet paper etc.)

Ziploc, bread and inner milk bags – clean and dry only please.

All plastic bags go in a “bag in bag system”.

**NOT** recyclable- dog and cat food bags, soil bags, planter pots, saran wrap, anything with paper labels, frozen food bags (veggies, fries) etc. Remember **“when in doubt, throw it out”**.

Also, we need to remember that **‘Some things are recyclable – the system just can't handle it right now’!** Like Styrofoam, there is simply no market for it, so instead of filling our landfill, we need to re-think our purchases based partly on packaging.

A re-use note. If you have large planter boxes or pots; instead of filling with soil, fill the bottom third or so with Styrofoam. It makes the planters lighter and easier to move. (MR)

A few things happening in October/November at your neighbourhood HCM Library!



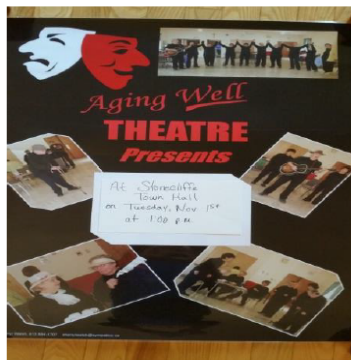
October 15 to 22 is **Public Library Week** – Drop in and enter your name for a chance to win 1 of 3 gift cards.
