- Follow up to Auto-Extrication actions... all resolutions were forwarded as directed by Council at its last meeting. Requests for information were sent. A letter to MTO in Ottawa requesting signage was sent. The following are responses received by the office to date.
- 2. The following is a response received from Bill Riley our insurer when asked about liability...

"Yes I do remember discussing this issue with you in the past. Your press release is quite succinct, in that you have identified that it is not a statutory requirement for you to provide this service under the Fire Protection and Safety Act and that it is a Provincial problem. As for liability there is nothing you can do to stop legal proceedings against the Township in the event of an incident. However the Township has the benefit of it is not your jurisdiction. Secondly you have the benefit of a defense based on economic reasons, a population of 250 cannot be expected to fund beyond their ability to pay and you can pass a resolution and to not provide a service for financial reasons.

Having said that, the Township has the benefit of liability coverage in the event you are named in a Statement of Claim." W. L. Riley, CIP, CCIB, President, MIS Municipal Insurance Services Ltd

3. In response to the letter asking for a retraction, Warden Emon has requested information about our "plan" prior to a decision being made which you have all been cc'd on...

"Good Morning Ms. Reith and members of County Council:

after the dissolution of the agreement on auto extrication. If possible could you provide the list of municipal, federal and provincial bodies you will be approaching and if possible can you demonstrate the list was developed prior to the dissolution.

Should someone ask me my opinion on the efforts to resolve the issue of Automobile Extraction I would not wish to suggest to any it was unfocussed and developed on the fly if in fact there was a plan in place to address the safety of the public prior to the dissolution of the agreement. I haven't been able to find it in your minutes and reports to council and of course would assume there is a plan and it has been posted, voted on by council and accepted and I missed it. Such a significant decision would of course need the support of a motion of council.
