**Subject:** Formalization of agreed incentive for increased diversion.

**RECOMMENDATION:** That Council pass the following resolution authorizing a rebate program for the purchase of composters as an incentive to increase diversion.

**WHEREAS** the goal of Council through the Waste Management By-Law adopted in December of 2011 is to reduce waste being landfilled and to encourage waste being diverted from landfill;

**Background/Executive Summary:** As part of the discussion which occurred in September of 2011 concerning the Waste Management by-law and encouraging diversion, Council considered rebating the costs of composters "up to 75%". Staff were to bring a resolution back to Council to formalize this decision and to set an upper limit.

Compostable materials account for a large percentage of the material left in garbage once the "normal" recyclables have been diverted. This refund was seen as an incentive to encourage increased diversion.

## Discussion/Considerations:

this program will end.

- A large number of residents already participate in composting.
- A large number of residents may not wish to participate due to the fear of unwanted pests/bears.
- Council could hold a workshop to explain the process of composting to avoid unwanted visitors.
- A newsletter could be produced using information from verifiable sources explaining how to compost effectively.
- Permanent residents only? How do we ensure that the composters are not taken "home"?

**Financial Considerations/Budget Impact:** Based on the 2011 census the number of private dwellings with usual residents is 103. Assuming that 10% of the population already has a composter there would then be 93 private dwellings without whose occupants may take advantage of this program.

Report to Council - Composter Rebate Program April 20-2012

There are funds in the surplus realized for 2011 which could be dedicated to this program. Once a certain limit has been reached, the program will end – a first come first served program. Of course the benefits will be realized only if participants make use of the composters in years to come. There is no way of controlling or estimating that. Public Education reminding people to compost would help – notices in the newsletters, signage at the disposal sites.
