- THAT 50% of 2011 tax rates for all classes of property are due March 31st as per by-law 2012 08.
- **THAT** the balance owing is to be split into 2 payments due July 31, 2012 and October 31, 2012.
- **THAT** a penalty of 1.25% per month be payable on all overdue current taxes, calculated on the first day of the month;
- **THAT** interest at 1.25% to be added on all tax arrears monthly on the first day of each month.
- **THAT** this By-Law is deemed to come into force and take effect on the 1st day of January 2012.

**Background/Executive Summary:** Self Explanatory. Without this by-law we will not be able to collect taxes. The rates listed are as per the County ratios and provide the municipality with the funds required to meet budgeted expenditures.
