- 2. Council further extends its gratitude to all those visitors and residents alike that chipped in and assisted in a large number of ways. Your contributions are noted and truly appreciated.
- 3. The Senior's New Horizon Fund application has been successfully completed and mailed with a request for funds to renovate and extend the kitchen and to purchase industrial/commercial appliances. Council reserves set aside for facility management will

- be required to complete the project in the amount of approximately \$9,000 should we be successful. Awards are to be announced in November.
- 4. Agrispirit grant has been submitted for new flooring for the hall.
- 5. Staff have been holding brief weekly meetings which has assisted in coordinating jobs which overlap disposal sites and roads. Although brief, the meetings ensure that we are all on the same page.
- 6. June Newsletter was created and distributed focusing on waste management, fire, Procedure By-law, use of off road vehicles etc. The next newsletter is scheduled for the first week of September. Please advise of any issues for inclusion.
- 7. Another funding opportunity has presented itself, again with funding for recreational facilities upgrades and renovations. Staff will prepare a submission for Council approval by the August 17<sup>th</sup> meeting.
- 8. On Thursday July 12, 2012 we had a "photo-op" with Cheryl Gallant which turned into an informative conversation with a promise to lobby on our behalf for additional Federal grants. Thank you Councillor Grills for filling in on short notice.
- 9. Drafts for signage have been obtained. Copy included for your information and comment.
- 10. Attended Land Claims meeting with Robert Labre and Reeve Stewart. Specific details are to be maintained confidentially. The bottom line is that there is still a long way to go (years); however things are moving quickly towards a draft agreement in principal. Council will be made aware of proceedings during special meetings to be held in the fall once the Algonquin's have been consulted.
- 11. The bin has been placed at the Stonecliffe/Mackey disposal site for collection of Waste Electronics.
