WHEREAS The Council of the United Townships of Head, Clara & Maria did receive and review the resolution of the Township of Muskoka Lakes calling for a review and correction of the Land Titles Electronic Registry System at the sole expense of the Ministry of Government Services;

AND WHEREAS electronic errors are causing financial challenges for our ratepayers and residents;

THEREFORE BE IT RESOLVED THAT this Council hereby supports this resolution and requests that the province work towards correcting the errors which occurred during the transition from paper based to electronic database especially as they relate to rights-of-way and land ownership in cottage country.

A request from the Ontario Forest Industries Association to lobby the provincial government to rethink their 24% cuts to forest roads.
