Subject: Support for Community Living with respect to a recent misunderstanding concerning area special needs adults and their parents in maintaining an exemption for minimum wage due to their inability to work to the same standard as others in order to maintain their employment.

## Resolution #1

**WHEREAS** recent concerns with Bill 148 and the demands placed on employers and the need to pay all employees a fair wage resulted in support for exemptions to parts of that Bill for persons with developmental disabilities in Ontario;

**AND WHEREAS** the Upper Ottawa Valley Community Living organization has reached out to the individuals at the front of that movement as well as the municipal councils in the region and have provided evidence of the success of their programs which ensures a fair wage for similar work for persons with disabilities;

**AND WHEREAS** the Community Living organization has worked, tirelessly to help break the stigma that someone with a disability should be treated as "lesser" in society than someone without and provide employment programs where adults with disabilities are treated fairly;
