SUBJECT: Building Permit Fee Schedule

RECOMMENDATION:

That Council update Schedule A to by-law 2007-06 to increase building permit fees.

BACKGROUND/EXECUTIVE SUMMARY:

*This report and the recommendation to Council have not changed. Council requested to have the municipality's Chief Building Official, Robert Labre attend Council to discuss the recommendations provided.

Our building permit fees are lower than most in the County of Renfrew and have not been reviewed since 2011.

The Building Code Act states building department services should generally be self-supporting. Permit application fees can be set at an amount that covers the cost to operate the building department (although the municipality could always choose to set fees at less than full cost recovery of service delivery). Therefore, delivery of building department services should generally not affect the municipal budget. However, the fees are not permitted to exceed the anticipated reasonable costs of the municipality to enforce the Building Code Act.

Total permit fees in Head, Clara and Maria for 2018 amounted to \$1331.51. The amount of revenues generated from building permit fees will vary greatly by year depending on the amount of construction in the municipality; however, revenues generated have not been enough to self-support the building department and increasing the permit fees will help narrow the gap.

Financial Considerations/Budget Impact:

Increasing building permit fees will increase revenues and help off-set building department fees. The amounts will vary depending on the amount of construction taking place in the municipality in any given year.

Below is a comparison of fees in surrounding municipalities. The proposed fee column for Head, Clara and Maria was determined in conjunction with our Chief Building Official.
