Welcome to the 2018 Summer Day Camp Program sponsored by the Healthy Kids Community Challenge and the United Townships of Head, Clara and Maria. Our goal is to provide a fun, safe and educational program that is not filled with screen time.

Program Information, Guidelines and Rules

The County of Renfrew is one of 45 communities across Ontario taking part in the Healthy Kids Community Challenge. The Challenge unites communities with a common goal of promoting children's health through healthy eating and physical activity. Approximately every nine months, the Ministry of Health and Long Term Care launches a new theme related to physical activity or healthy eating. The focus of this theme is limiting children's recreational and sedentary screen time.

Parent communication and cooperation are important in making this a successful program.

- Day Camp runs Monday to Thursday from August 13-23; 8:00 a.m. -4:00p.m. at the Stonecliffe Community Centre - 15 Township Hall Road, Stonecliffe, ON.
- Children may not be dropped off before 8:00 a.m. and must be picked up no later than 4:00 p.m.
Transportation to and from day camp on a daily basis is the responsibility of the parent/guardian, and not staff or volunteers.
- Children must be four years of age or older. Proof of age is required.
- A healthy, peanut free, lunch and snacks are required from Monday-Wednesday each week.
On Thursdays healthy snacks are required, lunch is provided through the program.
Allergies and/or dietary restrictions must be noted in this application form.
- Please label all children's belongings. We are not responsible for lost or stolen items.
- Electronic devices of any kind are not allowed at day camp.
If there is an emergency, or you need to speak to your child you may call the office and we will connect you to your child.
- Children will be expected to follow staff direction, plans and activities, and will be asked to leave if unable to do so. Inappropriate, unsafe behaviour will not be tolerated.
- Parents/guardians must be available to contact at all times while their child is at day camp, in case of emergency or child requiring pick up.

Waiver

I hereby authorize the staff of The United Townships of Head, Clara and Maria ("The Township") to act for me according to their best judgement in any emergency requiring medical attention for my child. I hereby waive and release The Township, its staff, volunteers and facilities from any and all liability for any injuries and illness' incurred while at day camp.
